## Project Newsletter

This is the first of many newsletters intended to provide interested community members with information about the Bell Bay Pulp Mill Project. We will provide this information regularly and encourage interested people to make contact with Gunns if they would like more information about the project.

Gunns is pleased to advise you that the next construction phase activity of the Bell Bay Pulp Mill Project will begin in August 2011. While the site has been cleared and made ready for earthworks for some time, Gunns Ltd has allocated a budget of some \$20 million for the next stage of construction of the \$2.3 billion project.

## Bulk Earthworks

This next phase will be "Bulk Earthworks", comprising a substantial level of on-site activity to be undertaken over the August 2011 to March 2012 period. Information on subsequent phases will be provided as those arrangements are finalised.

## Environmental management and controls

Gunns has all necessary environmental regulatory approvals in place.

A comprehensive regime of Federal and State approved surveillance monitoring will be in place. The Project's [Construction Environmental Management Plan](#) provides specific controls for the construction period, addressing aspects such as threatened flora, fauna, environmental noise, Aboriginal and historic cultural heritage surveys in line with the detailed conditions of State Permit and Commonwealth Approval.

The cleared area has been minimised as far as practical and hours of work, blasting time and frequency (2x per day) will be managed to reduce any disturbance to local residents, particularly those within the Rowella area.

Noise, vibration (from blasting), surface water run-off, ground-water and dust will be monitored carefully to assist with the environmental management of the construction site.

Surface water run-off will be managed intensively and, when the area dries out, as can be expected with the change of seasons, the operational environmental management will focus on the effective suppression of dust to prevent it causing nuisance to the closest residents.
